SELECTION JAMAICA OLYMPIC PROGRAM RELEASE AND WAIVER OF LIABILITY, PARTICIPATION OBLIGATION AND PARENTAL CONSENT AGREEMENT

In consideration of being permitted to participate in any way in the tryouts ("Tryouts") at Shashanya Productions, on behalf of myself and my personal representatives, assigns, heirs, and next of kin, that I:

- 1.) Hereby release, discharge, and indemnify Shashanya Productions, Jamaica Football Federation, their officers, directors, agents, employees and volunteers, other participants, any sponsors, advertisers, affiliates and, if applicable, owner and lessors of premises ("Releasees") on which the Tryouts take place from all liability, claims, demands, losses, or damages caused or alleged to be caused in whole or in part by the negligence of the Releasees including all expenses and costs incurred as a result of any claim.
- 2.) Acknowledge, agree, and represent that I understand the nature of the Tryouts and that I am qualified, in good health and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Tryouts.
- 3.) Acknowledge and understand that it is prohibited to enter into negotiations, selections or scouting activities, beginning with the date of the signing of this Agreement and until the final selection process and/or the completion of the Selection Jamaica Olympic Program Soccer Combine.
- 4.) Fully acknowledge and understand that I will be eliminated from the Tryouts if I negotiate with any soccer agent (or anyone offering me a contract to play professional soccer) while I am enrolled in the Tryouts.
- 5.) Fully acknowledge and understand that I have a contractual relationship with Shashanya Production Inc. If I violate this contractual relationship, I can harm the business interests Shashanya Production Inc. by impairing the proper operation of the soccer camp and damage the ability of Shashanya Production Inc. to receive sponsorships. I understand that parties interfering with this contractual relationship will be liable according to the law.
- 6.) The duration of the Soccer Combine Camp is up to six (6) months, or the date that Shashanya Productions, Inc., determines that the players are sufficiently prepared for the final selection, i.e. when they have totally completed the Soccer Combine Camp. At that point, the final selection will occur in a game played between the Selection Jamaica Olympic Program Soccer Combine TEAM, trained in the USA, and the players trained in Jamaica. The game between both teams will be played in the United States of America.

Accept the responsibility to actively participate in all of the Selection Jamaica Olympic Program Soccer Combine Camp activities and games until the completion of the program or at the direction of representatives from Shashanya Productions, Inc. and follow the instruction of the coaches and representatives/management of Shashanya Productions, Inc., in everything relating to the activities and games for the Selection Jamaica Olympic Program Soccer Combine Camp.
- 8.) Fully understand that the Tryouts involve risks and dangers of serious bodily injury including permanent disability, paralysis and death; these risks and dangers may be caused by my own or other's actions or inaction's, and/or the condition in which the Tryouts takes place or the negligence of the Releasees named that I fully accept and assume all such risks and all responsibility for losses, costs, and damages that may incur as a result of my participation or that of the minor in the Tryouts.
- 9.) Understand that at this event or related Tryouts that I may be photographed, and that I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and assigns.
